<b>Terms and conditions</b>	<ul style="list-style-type: none"><li>» All dogs (including puppies) must be registered within 14 days of acquisition or moving to Townsville.</li><li>» I must within 7 days give Townsville City Council notice of any changes to information provided on the registration notice.</li><li>» I understand that my dog/s must wear the registration tag at all times. A lifetime registration tag will be provided. A replacement tag will only be issued upon request (conditions apply).</li><li>» I understand that it is a requirement under the <i>Animal Management (Cats and Dogs) Act 2008</i>, that my animal has a permanent identification device (microchip) implanted.</li><li>» All dogs over the age of 12 weeks must be microchipped.</li><li>» Under the <i>Animal Management (Cats and Dogs) Act 2008</i>, the American Pit Bull Terrier or Pit Bull Terrier, Dogo Argentino, Fila Brasileiro (known as Brazilian Mastiff), Japanese Tosa or Perro de Presa Canario (or Presa Canario) breeds are subject to a restricted dog declaration and are prohibited by Townsville City Council.</li><li>» I have provided an adequate enclosure to prevent my animal from leaving or escaping the premises in accordance with the Townsville City Council Local Laws. I understand that failure to keep my animals within the enclosure could result in action being taken. Keeping of dog/s on a lead or runners is not considered an adequate enclosure.</li><li>» I acknowledge my dog/s must be walked on a lead or tether by a person who is physically able to control the animal.</li><li>» I acknowledge that I have read and understood the requirements and conditions required for keeping an animal under the Townsville City Council Local Laws.</li></ul>
