Purpose	<p>Exemption certificates to exempt development from assessment can be issued under either the <i>Planning Act 2016</i>, the <i>Queensland Heritage Act 1992</i> or the <i>Economic Development Act 2012</i>. If you are unsure about which legislation applies to your application, please contact Council's Planning Section to confirm.</p> <p>After your application is submitted, Council may issue a 'further advice' letter requesting more information or details be provided to help with assessing the request.</p> <p>A refusal from Council to issue an exemption certificate does not mean the proposed development is not supported in general. If your exemption certificate application is unsuccessful, the proposal may be lodged as an application for assessable development against the Townsville City Plan.</p>
