SUMMARY

Throughout the quarter, we continued our mission to grow Townsville, delivering projects that our community wants and needs. One such project is Ross River Dam recreational fishing, and we have commenced works on Stage 1, land-based fishing, to be opened next year. This is a project our community is passionate about.

Council also delivered essential upgrades to our active transport network, with Jezzine Boardwalk path upgraded and 300 metres of footpath replaced at Pallarenda. We also put Council's innovative new hedger to work, allowing shorter traffic lane closures and eliminating manual removal of waste. This speeds up our work and improves safety for our team and our community.



World Championship Triathlon

The World Triathlon Multisport Championships took place in August, drawing 3,000 competitors from more than 30 countries over a span of 12 days. This event was an international showcase of talent and determination, and once again placed Townsville on the global map.

The Championships benefited from the dedication of more than 1,000 volunteer shifts, generating \$80,000 in donations to local community groups, 30 motorbike riders and 4.6 km of crowd control fencing, all crucial for ensuring safety and smooth operation.

The event brought an impressive \$11 million economic boost, contributing over 41,000 room nights to local businesses. The exposure gained from hosting this international event significantly enhances Townsville's visibility and reputation, attracting future travellers, events, and investment opportunities.

Council Delivers Major Water Security Project

Council successfully completed a significant infrastructure project with the opening of the new 10-kilometre pipeline connecting Ross River Dam to the Douglas Water Treatment Plant. In collaboration with the State Government, this was developed over two years to enhance water security for Townsville.

The 1.29-metre-diameter pipeline was integrated into the existing system in June, with final revegetation works currently underway. The new pipeline now supplies 85 percent of Townsville's water, ensuring residents have access to this vital resource.

The project has been acknowledged as a finalist for the 2024 Australian Water Association Queensland Water Awards, highlighting its innovative approach to regional water management.



City Activation and Housing Incentive Policy



Council's Modernising Buildings Grant encourages Townsville building owners to apply as part of a key initiative within the City Activation and Housing Incentive Policy. The grant provides dollar-for-dollar matching funds up to \$30,000 for eligible projects aimed at refreshing, modernising, or upgrading buildings in Townsville City.

Over the past 3 years, more than 30 buildings have benefited from this initiative, contributing to the revitalisation of the city's streetscape.

Recent projects include the restoration of the iconic Speckled Hen Antiques, which utilised the grant to enhance its 146-year-old façade with new roofing, guttering, and touch-up painting. This demonstrates the grant's effectiveness in assisting building owners, especially those with heritage-listed properties, where renovation costs can be significant.

The Modernising Buildings Grant is part of a broader strategy to activate city streets and enhance Townsville's attractiveness, vibrancy, and safety.



Seniors Luncheon

Seniors Expo and Luncheon

The highly anticipated free Seniors Luncheon & Expo returned in August, marking one of the largest social events for Townsville seniors. Over 2,500 community members attended the Seniors Lifestyle Expo, while the Luncheon welcomed 1,620 patrons over two days.

The annual luncheon served as an opportunity to recognise the valuable contributions of seniors to the community. The Luncheon's theme encouraged attendees to wear their freshest florals and colourful attire, creating a festive garden party atmosphere. To increase accessibility, Council provided free transport from residences through TransitCare, Comlink, and Townsville Taxis.

Seniors also enjoyed the Seniors Lifestyle Expo which offered valuable information on aged care, retirement living, health care, financial services, and social opportunities in the city. With a diverse range of over 80 exhibitors, the expo aimed to provide resources that enhanced the lives of seniors in Townsville.





Ross River Dam land-based fishing construction

Ross River Dam – Stage 1 Recreational Use

Council voted to officially open the Ross River Dam to recreational land-based fishing next year. This decision followed a report presented at the Ordinary meeting, which approved a reallocation of funds from the 2024/25 Budget and Operations Plan to support Stage 1 of the recreation project.

Stage 1, scheduled for implementation by June 2025, will facilitate non-contact water activities such as land-based fishing and walking. The works will include essential improvements, including earthworks, new footpaths, toilets, and security infrastructure.

Jezzine Boardwalk Upgrades

As part of Council's \$328m infrastructure investment for 2024/25 Jezzine Boardwalk, one of Townsville's most popular pathways, is undergoing a decking upgrade.

The upgrade aims to enhance the visual appeal of the area while providing a safe and comfortable surface for visitors.
