#### **PART 1—PRELIMINARY**

#### 1. Short title

This local law may be cited as the V8 Supercars Event Parking Area Local Law 2011.

### 2. Objects

The object of this local law is to provide for Council's regulation of parking by time in a part of the City (a "parking area"); and

#### 3. Definitions

In this local law-

"City" means the area comprised in the City of Townsville under the Local Government Act 2009;

"Council" means the Townsville City Council;

"official traffic sign" has the meaning given to it in the Transport Operations (Road Use Management) Act 1995;

"park" has the meaning given to it in the Transport Operations (Road Use Management) Act 1995;

"parking area" has the meaning given to it in the Transport Operations (Road Use Management) Act 1995.

**"V8 Supercars Event Parking Area Resident Parking Permit"** means a parking permit issued by the Council to a person resident within the V8 Supercars Event Parking Area authorising that person to park a vehicle within that traffic area for a longer period than that depicted on the official traffic signs.

"V8 Supercars Event Parking Area Authorised Parking Permit" means a parking permit issued by the Council that authorises a person to park a vehicle within that traffic area for a longer period than that depicted on the official traffic signs.

#### PART 2 — THE V8 SUPERCARS EVENT PARKING AREA

#### 4. Parking area

The part of the City the boundaries of which are defined by the black bordering indicated on the map in the Schedule 1 is declared to be a parking area.

#### 5. Name of Parking Area

The parking area declared under section 4 is named V8 Supercars Event Parking Area.

#### 6. Regulation of Parking

Parking in the V8 Supercars Event Parking Area is allowed only for the maximum time specified on the official traffic signs at the dates and times specified on those official traffic signs.

Maximum penalty—25 penalty units Infringement Notice Penalty – 3 penalty units

## 7. Resident and Authorised Parking Permits

- (1) Section 6 does not apply to the parking of a motor vehicle displaying a "V8 Supercars Event Parking Area Resident Parking Permit" or a "V8 Supercars Event Parking Area Authorised Parking Permit".
- (2) The criteria upon which the Council will issue Resident Parking Permits and Authorised Parking Permits, and the process for applying for a permit is set out in Schedule 2.
- (3) A Resident Parking Permit or Authorised Parking Permit issued under this local law is valid only:
  - (a) for parking within the V8 Supercars Event Parking Area; and
  - (b) during the period shown on the permit, and
  - (c) while the parking permit is publicly displayed within the vehicle.

# SCHEDULE 2 — RESIDENT PARKING PERMITS AND AUTHORISED PARKING PERMITS

| (1) | No fee is payable for the issue of a Resident Parking Permit or an Authorised |

- (2) To be eligible for a Resident Parking Permit, an applicant must be an owner, occupier or tenant with a lease of 6 months or more of a residential premises within the V8 Supercars Event Parking Area.
- (3) Resident Parking Permits will not be issued to non-resident landlords, hotel guests, occupants of serviced apartments or people who do not reside at an address full-time.
- (4) An application for a permit must be made in person at any Council Customer Service Centre, and the applicant must produce a copy of a recent rates notice, tenancy agreement (of 6 months or more) or a copy of a current driver's licence, showing a residential address within the parking area.
- (5) Each eligible applicant may request one or two Resident Parking Permits without providing further evidence to the Council. An applicant who seeks more than two parking permits may be required to provide additional material to establish that the resident has a genuine need to park more than two vehicles at the premises during the period in which parking is regulated under this local law.
- (6) Authorised Parking Permits will be issued to persons who satisfy the Council that, because of a business or other connection to the Parking Area, they have a need to park a vehicle within the area for a period exceeding two hours during the period in which parking is regulated under this local law. The number of Authorised Parking Permits issued to each applicant will be based upon the need for parking that the applicant establishes to the Council.
- (7) Resident Parking Permits and Authorised Parking Permits will apply only to registered vehicles.
