## Purpose

You are generally allowed to keep up to two dogs on a property. This application is for approval to keep up to four dogs on a property between 400m<sup>2</sup> and 4000m<sup>2</sup>. All dogs must also be registered and microchipped.

Approvals are valid for three years, and Council officers will inspect the property as part of the approval process (by appointment). Application fees are non-refundable.

## Conditions of Approval

These are in addition to the conditions listed in Schedules 4 and 5 of the Subordinate Local Law 2 (Animal Management) 2011 for the keeping of dogs.

The Approval holder must:

- care for the dogs in accordance with minimum standards; and
- keep the dogs in enclosures that comply with minimum standards; and
- ensure the dogs are registered and kept registered annually with the Townsville City Council; and
- ensure that the dogs wear or display an appropriate identifying tag; and
- ensure that the dogs do not cause nuisance.

The approval:

- is for the person and the property applied for; and
- may be revoked if Townsville City Council should receive any substantiated complaints; and
- must be renewed every 3 years.

**Any dogs obtained, purchased or acquired are now required by law to be microchipped. Puppies are required to be microchipped before 12 weeks of age.**
