## 1 Construction and Maintenance - Tender T6450: Magnetic Island Walkways Design and Construct Contractor

### Executive Summary >>

Council is undertaking the Magnetic Island Walkways, Nelly Bay to Arcadia project, which includes the construction of an elevated walkway, retaining walls and footpaths located between Nelly Bay and Arcadia. The project requires the professional services of a Design and Construct Contractor to take the "design development" documentation to "for construction" documentation and to construct the project.

The purpose of this report is to award the tender to an appropriate skilled and qualified contractor. The tenders were reviewed in accordance with a detailed evaluation plan and a copy of the evaluation report, including its unanimous recommendation, is attached to the agenda item.
