**Approved Pensioner** - is a person who:

- is and remains the holder of a Queensland "Pensioner Concession Card" issued by Centrelink or the Department of Veterans' Affairs Health Card (All conditions within Australia) or Department of Veterans Affairs Health Card (Totally and Permanently incapacitated).

**PART 22.A >> ANIMAL MANAGEMENT RENEWAL**

Reciprocal registration is a transfer of the balance of the current year's registration of an animal (other than a regulated dog) from one local government area to another. You still need to complete a dog registration form, but there is no fee to register in the current registration period. You will need to use the PDF form available at [https://www.townsville.qld.gov.au/\\_data/assets/pdf\\_file/0007/3400/Application-for-dog-registration-form-EHRS-November2-2019.pdf](https://www.townsville.qld.gov.au/_data/assets/pdf_file/0007/3400/Application-for-dog-registration-form-EHRS-November2-2019.pdf) if applying for reciprocal dog registration.
