(i) Information sharing

Cayley Downey noted the importance of ensuring that useful information is well promoted. Councillor Margie Ryder supported this comment.

(ii) Toilet facilities in Anderson Gardens

Vicki Trevanion noted that there are no toilet facilities in Anderson Gardens, which impacts on accessibility. The Chair, Councillor Liam Mooney, noted that Palmetum also doesn't have toilet facilities and suggested that this be investigated further. The committee noted that the review of the inclusive access guide would identify the lack of amenities in certain areas.

Meeting action

The Chair, Councillor Liam Mooney, to investigate the status of toilet facilities in Anderson Gardens and Palmetum and report back to the committee.

(iii) Agenda submissions

The Chair, Councillor Liam Mooney, welcomed agenda submissions for the 2023 committee meetings.

(iv) LGBTIQ+ as round table discussion topic

Matthew Higgins suggested that the LGBTIQ+ topic (action item 22-9) be discussed as a round table topic. The Chair, Councillor Liam Mooney, agreed that this topic could be added to the agenda for the next committee meeting.

(vi) Townsville Multicultural Support Group Anniversary

Matthew Higgins praised the work of the Townsville Multicultural Support Group, which recently celebrated their 30th anniversary.

(vii) Townsville Enterprise invitation

Matthew Higgins suggested that the committee invite a Townsville Enterprise representative to talk about the designated area migration agreement. The committee agreed with this suggestion.

(viii) Multicultural event grants

Matthew Higgins noted that some Queensland government grants had been awarded recently for multicultural events in Townsville.

Stephanie Naunton noted that the Townsville Multicultural Support Group has restructured and will soon be unified with Multicultural Australia.

Stephanie Naunton queried when the LGBTIQ+ working group (action item 9) would commence and the Chair, Councillor Liam Mooney, confirmed that nominations for the working group were now open.

(xi) Accessibility focus

Maria Hutton noted that she was pleased with the committee's focus on accessibility issues.

(xii) Human Rights Week

Anne Herbert noted that Human Rights Week is 1-10 December 2022, and that she will provide the 2023 calendar of events for the Human Rights Commission Queensland to the Meeting Facilitator once available.

(xiii) LGBTIQ+ action item

The committee agreed to amend Action Item 9 " Establishment of LGBTIQ+ focussed discussion Working Group" and have the topic discussed as a round table topic instead of a working group.

Councillor Margie Ryder and Cayley Downey left the meeting at 11:35am before the following agenda item.
