

Reusables Rebate 2024



PROMOTER	The Promoter is Townsville City Council ("TCC"), ABN 44 741 992 072, of 103 Walker Street, Townsville, Queensland 4810.
PROMOTION PERIOD	The Reusables Rebate program ("Promotion") will commence at 12.01AM AEST, 15 April 2024 and will conclude on:  • 30 June 2024; or  • the date the funding for the Promotion has exhausted  ("Promotion Period").  The Promoter will notify the community as soon as practicable if the funding for the Promotion has been exhausted by notification through the website.
WHO IS ELIGIBLE TO APPLY?	The Promotion is open to all people residing in the Townsville City Council Local Government Area. Information on the Townsville Local Government Area can be found here: <a href="https://www.townsville.qld.gov.au/about-townsville/living-in-townsville/townsville-community-profiles">https://www.townsville.qld.gov.au/about-townsville/living-in-townsville/townsville-community-profiles</a> If applicants are under the age of 18, applicants must have a legal guardian's permission to make an application.  Applicants must purchase eligible products between 15 April 2024 - 30 June 2024 to be eligible to apply for the rebate.
HOW IS THE REBATE APPLIED?	The rebate will be applied in the form of a digital Visa Prepaid Giftcard. These gift cards may be spent online or at any store that accepts digital Visa prepaid cards.  All cards will be subject to the terms and conditions of the card issuer which is available at Terms & Conditions   Corporate Prepaid Cards (corporateprepaidgiftcards.com.au) . The Cards have an expiry date 12 months from its issue date which can be found on the front.  For successful applicants to receive the rebate:  • You must have a device capable of receiving SMS and downloading applications.  • Follow the instructions on the SMS you received with your card information. This will include downloading the Universal Gift Card App. The Universal Gift Card app works with most Android and Apple devices. However, it may depend on the age of your device.  • Must provide to the card issuer personal details including but not limited to, full name, address, phone number, date of birth and email address. This information is required to receive the reusable rebate.  • Applicants must complete the instructions included on the SMS before the allocated time frame of 6 months.  • Applicants phone number must be current and match that to the one on the applicant's application.  If the SMS needs to be resent, this will be at the cost of the applicant. There will be a \$4.40 fee withdrawn from the applicants Prepaid Visa Giftcard by the supplier.

WHAT ARE THE ELIGIBLE PRODUCTS?	Applicants may, during the Promotion Period, apply for a rebate on any of the following eligible products purchased between 15 April 2024 and 30 June 2024:  • cloth and reuseable swim nappies, • reusable inner liner for nappies, • reusable wipes, • reusable nursing breast pads, • reusable cloth sanitary pads, • reusable menstrual cups, • reusable period and/or incontinence underwear • wet bags designed for the storage and transport of soiled reusable items, • other associated accessories such as fastener and clips.
HOW MUCH CAN I APPLY FOR?	<ul> <li>Applicants can apply for 50% of the purchase price of an eligible product.</li> <li>A maximum rebate of \$200 is permitted on:         <ul> <li>cloth and reuseable swim nappies; and</li> <li>reusable inner liner for nappies.</li> </ul> </li> <li>A maximum rebate of \$100 is permitted on other eligible reusable products.</li> <li>Applicants can claim a total rebate of \$300 between all eligible products.</li> <li>There is a minimum product purchase of \$50 (per application) to be eligible for the rebate.         <ul> <li>For example, an applicant purchases an eligible item for \$50.00, they will receive a rebate of \$25.00 (50% of the purchase price).</li> </ul> </li> <li>The rebate does not cover any cost or expense incurred by applicants for the postage or delivery of any of the above products.</li> </ul>
HOW DO I APPLY? Applications must be lodged by 5pm on 30 June 2024 or prior to the allocated funds being exhausted.  Incomplete applications and applications made after 30 June 2024 or after the date the allocated funds are exhausted, will not be considered by the Promoter.  Application forms must be accompanied by:  • the applicant's contact details including phone number and email address to receive communications relating to the reusables rebate; • an applicant's proof of residency in the Townsville City Council Local Government Area (i.e rates notice, utility bill, driver's licence noting current residential address); • evidence of proof of purchase of the eligible; and • if an applicant is under the age of 18, the applicant must submit evidence of their legal guardian's consent as part of their application.  The evidence of proof of purchase must note the following:  • date of purchase (must be between 15 April 2024 and 30 June 2024); • supplier's name and ABN (if applicable); • eligible product names and cost of the Eligible Products (underline each eligible product if multiple items are listed on the receipt); and • confirm you have paid for the eligible products (e.g. contain the words 'receipt', or 'payment received' or similar).

The phone number supplied as part of the applicant's application form will be the number which the Visa Giftcard will be sent to.
