

PERCIVAL PHOTOGRAPHIC PORTRAIT PRIZE 2020

The *Percival Photographic Portrait Prize* returns for the fourth instalment since it first debuted in 2014.

The *Percival Photographic Portrait Prize* was started to coincide with the highly popular *Percival Portrait Painting Prize* and to ensure a city-wide celebration of portraiture.

The exhibition, which has been growing with every edition, offers a major \$10,000 acquisitive prize.

CONDITIONS OF ENTRY

Entry is in accordance with and is deemed acceptance of these conditions and the Entrant (Artist) is bound by and shall perform and observe all obligations upon the Artist pursuant to these conditions.

The *Percival Photographic Portrait Prize* is awarded by Perc Tucker Regional Gallery, Townsville City Council.

Entry is open to all local, interstate and international Artists.

Artists are advised that the maximum allowance for artworks to enter the building is 200 cm in height. Whole artworks that exceed this size will not be eligible.

Entry in the Prize is through pre-selection from photographs and digital image/s of each artwork entered. Artists are **NOT** to submit original works of art for the pre-selection process.

Artists are required to submit:

- A digital image of each artwork in .TIFF or .JPEG format on a USB thumb drive OR via an online file transfer service such as Dropbox.
- A completed and signed entry form
- The Artist's curriculum vitae
- ABN or [Statement by Supplier Form](#)
- Electronic Artist statement related to the entry (no more than 300 words) in .DOC or .RTF format
- A non-refundable administration fee of AUD \$44 per entry

The Percival Photographic Portrait Prize is open to all forms of still photography and must be a 2D portrait of a human subject to be considered for pre-selection and prize. All artworks entered by the Artist must be the original work and concept of the Artist.

An Artist may enter up to 3 entries for pre-selection, but each entry must be accompanied by a separate entry form and fee with all relevant supporting material.

A third party may not enter any works on behalf of an Artist.

Perc Tucker Regional Gallery reserves the right to reject entries that do not comply.

Entry forms are to be received no later than **5pm Monday 2 March 2020**. Late or incomplete entries will not be accepted. All entries are to be submitted and delivered free of all charges.

An entry shall impose an obligation upon the Artist to submit the entered work for exhibition if selected.

ACCEPTANCE AND EXHIBITION

Works selected for exhibition will be as chosen by a panel of judges appointed by Perc Tucker Regional Gallery. Artists will be advised of the outcome from pre-selection on or before Friday 27 March 2020. Selected Artists will be notified by email.

Artists whose works are selected for exhibition must allow their work to be reproduced for the promotional, review and educational purposes and/or the future promotion of Townsville City Galleries, Townsville City Council, and the exhibition sponsors, and entry is and shall be deemed authorisation by the Artist to these parties. All selected artworks can be displayed framed or unframed.

All selected photographic works must be suitably framed. Works printed on fabric or canvas and stretched are considered framed. Flat D-rings must be placed at back of the work 10 cm down from top of frame.

Artworks will be put on display for the duration of the competition and shall not be removed before Monday 20 July 2020. Perc Tucker Regional Gallery will not exhibit any work forwarded for exhibition which is not the submitted entry.

DELIVERY OF ARTWORK

Successful entries are to be delivered to Grace Worldwide **strictly** between Tuesday 5 and Thursday 7 May 2020. Artworks delivered to Perc Tucker Regional Gallery will not be accepted.

PRICING AND SALE OF ARTWORK

The sale price indicated in the entry form shall apply and shall remain fixed for the duration of the exhibition. This price must take into consideration the 30% Commission to be taken by Perc Tucker Regional Gallery.

Should an entry be sold, the net sale proceeds will be paid to the Artist within thirty (30) days of sale, provided settlement has been made in accordance with the conditions of sale. Payment will be made in Australian dollars.

PACKAGING AND FREIGHT

All entries must be securely packed, and packaging should be suitable for return.

Artworks that are not wrapped suitably for travel will not be accepted.

The cost of freight and insurance for works selected for exhibition will be the responsibility of the Artist. If consigning artwork via post or carrier, return freight must be arranged by the Artist.

No payment whatsoever will be made by Perc Tucker Regional Gallery for freight or other charges incurred in the delivery or return of entries.

After the close of the exhibition all works not sold must be collected from **Perc Tucker Regional Gallery** between the hours of 9am – 4pm Monday 20 – Tuesday 21 July 2020 and it is the responsibility of the Artist to ensure the packing material is sufficient for the return transportation of the work.

Upon collection of the artwork, the Artist must sign a collection receipt. If another person will be collecting on the behalf of the Artist, this person must be nominated to Perc Tucker Regional Gallery in advance.

Where arrangements have not been made for collection or return freight by the due date, the Gallery reserves the right to sell or otherwise dispose of the work on the expiration of thirty (30) days from the last exhibition day.

INSURANCE

Perc Tucker Regional Gallery and Townsville City Council will not be responsible for any loss or damage whatsoever, however caused, to any work whilst in the Gallery's custody. Each Artist is and shall be responsible for maintaining their own insurance cover.

JUDGING AND AWARDS

Perc Tucker Regional Gallery will appoint an industry-recognised figure to judge, select and announce the prize-winning work. **The judge's decision will be final and correspondence will not be entered into.**

Winning works of acquisitive prizes shall be acquired for the amount of the prize indicated on the entry form, not any higher.

PRIVACY COLLECTION NOTICE

Townsville City Council collects and manages personal information in the course of performing its activities, functions and duties. We respect the privacy of the personal information held by us. The way in which council manages personal information is governed by the Information Privacy Act 2009 (Qld). We are collecting your personal information in accordance with Local Government Act 2009 in order to select, exhibit and promote submitted art works in the Percival 2020 events, displays and public programming. Details will be retained for no purpose unrelated to exhibition. Generally, we will not disclose your personal information outside of Council unless we are required to do so by law, or unless you have given us your consent to such disclosure. However, in performing the above functions, we will need to disclose your personal information to the independent judging panel and your name and art work details could be displayed on promotional materials both physical and online.
