Conditions Local law requirements must also be met	<ol style="list-style-type: none"> All cats must be microchipped from 12 weeks of age. All reasonable steps are taken to prevent the cats from causing a nuisance or disturbance to the occupiers of other premises. Any enclosure in which the cats are kept is properly drained and run-off is prevented from entering adjoining land. Any enclosure in which the cats are kept is maintained in a clean and sanitary condition, disinfected regularly and kept in good condition. Any material that is, or is likely to become, offensive is collected daily and, if not immediately disposed of, is kept in a waste container approved by council. This approval is only valid for the person at the address stated above. You must advise council if you change address or no longer require approval. The cats must be kept in accordance with the minimum standards for the species prescribed in Schedule 5 of <i>Subordinate Local Law No. 2 (Animal Management) 2011</i>. Any breach of these conditions may result in withdrawal of the approval.
