<b>Conditions</b> Local law requirements must also be met	<ol style="list-style-type: none"> <li>1. All cats must be microchipped from 12 weeks of age.</li> <li>2. All reasonable steps are taken to prevent the cats from causing a nuisance or disturbance to the occupiers of other premises.</li> <li>3. Any enclosure in which the cats are kept is properly drained and run-off is prevented from entering adjoining land.</li> <li>4. Any enclosure in which the cats are kept is maintained in a clean and sanitary condition, disinfected regularly and kept in good condition.</li> <li>5. Any material that is, or is likely to become, offensive is collected daily and, if not immediately disposed of, is kept in a waste container approved by council.</li> <li>6. This approval is only valid for the person at the address stated above. You must advise council if you change address or no longer require approval.</li> <li>7. The cats must be kept in accordance with the minimum standards for the species prescribed in Schedule 5 of Subordinate Local Law No. 2 (Animal Management) 2011. Any breach of these conditions may result in withdrawal of the approval.</li> </ol>			
<b>Microchips</b>	Any cats obtained, purchased or acquired are now required by law to be microchipped. Kittens are required to be microchipped before 12 weeks of age.			
<b>Applicant declaration</b>	I hereby apply for approval to keep between three to six cats, and declare that the particulars provided on this form are true and correct in every detail. I agree to comply with Council's conditions as set out in this form, including any local law requirements.
