1 Northern Australia Policy - ADC Forum

Executive Summary

The Federal Government is proposing to develop a Northern Australia Policy and has established a Joint Select Committee to review and make recommendations concerning such a Policy and tasked bureaucrats from the Department of Prime Minister and Cabinet to draft a White Paper on Northern Australia. The White Paper is due to be finalised toward the end of the year and will inform the Northern Australia Policy.

Council is working in partnership with Townsville Enterprise Limited and the Chamber of Commerce to prepare a submission to the Joint Select Committee on Townsville's strengths as the largest City in Northern Australia. A number of key stakeholders including the Port of Townsville and James Cook University (JCU) will have input to our joint submission.

Members of the Joint Select Committee propose to visit Townsville over coming months to meet with local stakeholders and to appreciate firsthand what Townsville has to offer. Similarly representatives of the Department of Prime Minister and Cabinet have recently visited Townsville and met with the Mayor, Councillor J Hill and Chief Executive Officer and others.

An organisation called the ADC Forum has made representations to the Mayor for council to sponsor a Northern Development Summit in Townsville that will seek to further inform the Federal Government's White Paper. The sponsorship sought from council is \$100,000. ADC Forum is also seeking sponsorship through Townsville Enterprise Limited from local businesses, from JCU and from the Federal Government.

The ADC Forum describes itself as 'a wholly Australian, non-political, not-for-profit leadership organisation which brings together leaders from business, government, the public sector, academia and the broader community to improve their understanding of key issues affecting Australia'. A fact sheet on the ADC Forum is attached to the Report to Council.

The Northern Development Summit is proposed to include as speakers and attendees key national and local stakeholders who are experts in their field across the range of relevant industries and businesses that will be impacted and potentially benefit from a Northern Australia Policy. The Summit promises high national media exposure for Townsville.

The Mayor has been invited to sit on the Planning Committee for the proposed Summit and the JCU Vice-Chancellor Sandra Harding is also involved.

It is proposed to convene the Northern Development Summit in June this year.

ADC Forum has forwarded a draft contract for the council sponsorship of the Northern Development Summit a copy of which is attached to the Report to Council. The draft contract proposes that council:

- assign a staff member to liaise with ADC in the administration, programming and management of the Summit;
- nominate a senior representative to address a Plenary Session at the Summit; and participate in a Summit Working Group which will report its findings to the Summit;
- consult with ADC in the development of the Summit program;

- receive four complimentary registrations to the Summit;
- be acknowledged in the Summit official program, handbook and signage throughout the Summit proceedings;
- be permitted to include its logo on ADC website for the Summit and include up to four items of promotional material in Summit participation packs; and
- become a corporate member of ADC for one year.

Officer's Recommendation

- 1. That council agree to sponsor the ADC Forum to convene the Northern Development Summit in Townsville to the sum of \$100,000 funded over two financial years 2013/14 and 2014/15 and that the Chief Executive Officer be authorised to sign the sponsorship contract (as amended) with ADC and subject to satisfaction regarding the relevance of the list of program speakers and topics.
- 2. That council note that \$50,000 of the sponsorship can be funded from council's Economic Development budget in 2013/14.
- 3. That council note that \$50,000 will be included in the Economic Development Budget in 2014/15 for part sponsorship of the Northern Development Summit.
- 4. That council endorse the Mayor, Councillor J Hill's participation on the ADC Forum planning committee for the Northern Development Summit.
- 5. That council receive and note the submission lodged jointly by Townsville City Council, Townsville Enterprise Limited and the Townsville Chamber of Commerce to the Joint Select Committee for Northern Australia.

It was MOVED by the Mayor, Councillor J Hill, SECONDED by the Deputy Mayor, Councillor V Veitch:

"that officer's recommendations 1 to 4 be adopted."

The Chief Executive Officer requested that officer's recommendation 5 be held over for discussion at a subsequent meeting as the joint submission is currently under development and the closing date for submissions has been extended to 14 March 2014.
