This year, the Mayor's Christmas Appeal, through local not-for-profit community organisation/s, will distribute and use funds raised to support people experiencing financial hardship over the Christmas period, with an extended option to also promote direct goods donations from community to not-for-profit community organisation/s.

How the Mayor's Christmas Appeal 2025 is providing support	Dependent on level of donations received, it is the intent of the Appeal to provide a cash donation to successful Applicant/s to in turn, distribute and use those donated funds to support Townsville people who are experiencing financial hardship over the Christmas period, with the extended option for the successful applicant/s to be promoted to receive direct goods donations from the community.

Definition of the Christmas period for the purpose of the Mayor's Christmas Appeal	Between 1 December 2025 and 31 January 2026.
Define the Applicant	The Applicant is the local Community Organisation.
Who can apply	 Applicants must meet all of the below to be considered for funding: Be properly constituted as a not-for-profit organisation; Support people experiencing financial hardship; Located in Townsville and service clients who are residents of the Townsville City Council Local Government Area; Must be free of debt to Townsville City Council; Not be a part of a larger organisation with a national or international body; and Able to distribute/use the Appeal donation to support people experiencing financial hardship over the Christmas period.

Reporting requirements for successful applicants	 All successful Applicants will be required to complete an outcomes report in SmartyGrants by 27 February 2026, which will include the following: Number of people assisted. How the use of funds supported people experiencing financial hardship over the Christmas period. Total funds spent. Indication of number of items and types of goods directly donated by the community. Failure to submit an outcomes report that meets Council's standards may lead to your organisation being ineligible to apply for future funding from Council amongst other remedies available at law. Council reserves the right to print or publish outcomes reports information for the purpose of promoting and/or reporting on the Appeal.
