

TERMS & CONDITIONS



The Buzz - Eco Fiesta Video & Creative Competition

PROMOTER	The Promoter is Townsville City Council (" TCC "), ABN 44 741 992 072, of 103 Walker Street, Townsville, Queensland 4810.
PROMOTION PERIOD	The competition (" Promotion ") will commence 4 March 2022 and closes 5pm AEST, 20 May 2022. (" Promotion Period ").
HOW TO ENTER	During the Promotion Period, the Promoter will provide an online entry link via Woobox. Eligible Entrant's can enter the competition by uploading their video and providing personal details to TCC via the Woobox link located on TCC's website.
WHO CAN ENTER	The Promotion is open to all people in the TCC Local Government Area. Employees of the Promoter or their family members or anyone else connected in any way with the competition or helping to set up the competition shall not be permitted to enter the competition. To be an Eligible Entrant and receive one of the prizes the winners will be required to correctly complete the Woobox page and provide Council with their personal details. If under 18 years, the Eligible Entrant must have a legal guardian's permission to provide the requisite details and upload an entry.
SELECTION OF THE PRIZE WINNERS	The Promoter will select a panel of three judges who will choose the winners. The winners (3) will be chosen and notified via the contact details provided. The winners will be contacted by a TCC representative by 5pm, 30 May 2022. All decisions by the Promoter regarding winning entries are final.
PRIZES	Three major prize winners in the Open Category. Open Category First Prize is \$5000 Open Category Second Prize is \$3000 Open Category Third Prize is \$1000 The prizes must be taken as stated and cannot be exchanged for alternate prizes or offers.
NOTIFICATION OF WINNERS	The winners will be contacted via the provided contact details no later than 5:00pm 30 May 2022. The winners, winning entries and prizes will be presented at Eco Fiesta Film Night, 4 June 2022.

PRIVACY STATEMENT

Townsville City Council collects and manages personal information in the course of performing its activities, functions and duties. We respect the privacy of the personal information held by us. 10. Ensure that all content in your film (including footage, music, images, props, etc.) is your own. If you include any copyrighted or trademarked content, you must be able to provide written permission for its use. Entries containing any unauthorised content will be disqualified.

12. The Promoter reserves the right to refuse any group or person entry into the Promotion at any time.
