# Item 2 Introduction: Jane Scott, Galleries Director, Townsville City Council

Jane Scott gave a brief description of her previous experience and her current focus with the galleries in Townsville.

# Item 1 Introduction: Jacqui Cowell, General Manager Community and Lifestyle, Townsville City Council

Jacqui Cowell gave a brief description of her previous experience and asked other members of the Advisory Committee to introduce themselves and their organisations.

General Manager Community and Lifestyle and Coordinator Grants and Partnerships noted that Council's grants program is currently being reviewed, and asked members their views and feedback on the grants program.

Members of the Advisory Committee provided feedback on the needs of arts and cultural organisations in the city including the following:

- There is a need for suitable equipment and archival storage space.
- Concern was expressed about the availability of rehearsal and performing facilities. Members of the committee noted that two performing spaces had recently closed or would be closing shortly – Riverway Performing Space and PIMPAC at the Pimlico State High School.
- There is a need for operational grants funding for organisations catering to grassroots-type activities. Committee members noted that many arts and cultural groups in the city operated as more of a community service and are unlikely to be able to develop operational self-sufficiency.
- The grants application process can be difficult and more support from Council
  Officers would be welcome, including helping to identify suitable grants, providing
  constructive feedback on the proposed activity (e.g. how to improve the likelihood
  of success) and providing guidance around the best way to describe the activity in
  the application.
