## 22-6 Maritime Museum – Installation of plaque near site of former HMAS Magnetic

#### **Committee Recommendation**

That the Committee supports in principle Maritime Museum's proposal for the installation of a plaque that recognises the significant contribution of HMAS Magnetic dependent on funding and that Councillor Kurt Rehbein provide a letter of support.

The Meeting Facilitator advised the Committee that the Maritime Museum have applied for grant funding and are awaiting confirmation that it has been accepted.

# 22-7 National Trust of Australia (Queensland) – Unmarked grave in Belgian Gardens Cemetery

#### Ray Holyoak to bring back more information to the Committee on Sidney Wise's lineage

Ray Holyoak provided the Committee with a brief verbal overview of Mr Wise's lineage.

This action item is complete.

#### The Meeting Facilitator to follow up on a cost estimate for a headstone / marker

The Meeting Facilitator informed the Committee that the total cost estimate for a headstone/ marker with etching or inscribing is \$2,500.

#### 3. Councillor Kurt Rehbein to discuss the proposal with Local Unions

Councillor Kurt Rehbein informed the Committee that he discussed the proposal with the General Secretary of the Queensland Council of Unions.

Ray Holyoak informed the Committee that he will continue research with the Queensland State Archives on whether Mr Wise was a union member.

The Meeting Facilitator noted that there are currently no known grant streams for this type of project.

Councillor Rehbein advised the Committee that he would follow the proposal up with a union representative in that profession now.

#### 21-8 Meeting Action

The Chair, Councillor Kurt Rehbein requested that the nomination of a prominent Townsvillean for recognition in the city be held over to the next Committee meeting for a Committee Recommendation.

The Meeting Facilitator recommended this action item be brought back to the next Committee meeting with a specific proposal for the commemoration of Captain W.F MacIntosh.

Geoff Hansen provided an update on the progression of the proposal.

Geoff Hansen advised the Committee that he will reach out to Mark Smith the Manager of the Museum to consider options around the walkway at Jezzine Barracks.

#### 22-8 General Business (ii) Oonoonba Bombing Memorial

The Meeting Facilitator to come back to the next Committee meeting with who owns the land and is responsible for the maintenance of the monument.

The Meeting Facilitator informed the Committee that the land is owned by the Minister of Economic Development Queensland and is on the Register of Public Art. The Meeting Facilitator noted that the memorial itself is a Townsville City Council asset.

## (i) Agency Reports from Committee Members

Councillor Rehbein advised that the Meeting Facilitator is following up on this query and asked the Committee if any members could assist.

#### (iii) The Weekend Australian Inquirer - Neglected Heritage

Geoff Hansen tabled an article from the Weekend Heritage on June 18-19, 2022, titled 'Neglected Heritage' and provided a brief overview.

## (iv) Verbal Update - Unmarked grave in Belgian Gardens Cemetery

Marilyn Grogan provided a verbal update of information on Sidney Wise from the Family History Association North Queensland.

### (v) Heritage Day 2023

The Meeting Facilitator advised the Committee that the "Our Townsville" event, incorporating elements of Heritage Day will be on 3 and 4 June 2023.

#### (vi) Funding Approval for Open House Series in Townsville

The Meeting Facilitator advised that initial funding has been provided to investigate the logistics and requirements of Townsville hosting an Open House event. Council is interested in understanding any suitable places in Townsville and if Committee members would like to contribute ideas. The Meeting Facilitator noted that they are looking at two places with free access and are not readily accessible any other time.

## (vii) Highways and Byways Revision

The Meeting Facilitator advised that two adjunct instructors from James Cook University have assisted in adding raw information to the Highways and Byways Revision put together by John Matthew and that an update will be provided at the next committee meeting.

## (viii) Maps of Toolakea Beach

Marilyn Grogan informed the Committee that an existing member of the Family History Association North Queensland is completing a history report on Toolakea Beach and asked whether Townsville City Council have old maps from the 1950s and 1960s.

## (ix) Air Raid in Many Peaks

Marilyn Grogan referred to a personal matter regarding the air raid at Many Peaks in Shelley Beach and asked for the Committee's assistance.
