#### 1. Short title

This subordinate local law may be cited as the *Subordinate Local Law No. 9* (Stadium Parking Area) 2022.

#### 2. Purpose and how it is to be achieved

- (1) The purpose of this subordinate local law is to supplement *Local Law No.* 9 (Stadium Parking Area) 2022 which provides for Council's regulation of parking by time in a part of the City (a "parking area") when that is desirable because of an event at North Queensland Stadium.
- (2) The purpose is to be achieved by providing for—
  - (a) The boundaries of any Parking Area declared under section 4 of the local law;
  - (b) The categories of Parking Permits that the Council will make available under section 6 the local law;
  - (c) The criteria upon which the Council will issue each category of Parking Permit;
  - (d) The conditions attaching to each category of Parking Permit; and
  - (e) The process for applying for a Parking Permit.

### 3. Authorising Local Law

The making of the provisions in this subordinate local law is authorised by *Local Law No.* 9 (Stadium Parking Area) 2022 (the **authorising local law**). In this local law—

#### 4. Definitions

Particular words used in this subordinate local law have the same meaning as provided for in the authorising local law.

### 5. Declaration of regulated parking area — Authorising local law, s. 4

For section 4 of the authorising local law, the part of the Townsville local government area the boundaries of which are defined by the pink and blue bordering indicated on the map in Schedule 1 is declared to be the Stadium Parking Area.

# 6. Parking permits—Authorising local law, s 6

- (1) This section prescribes—
  - (a) the persons that may be issued with a parking permit mentioned in section 6 of the authorising local law; and
  - (b) the circumstances in which the parking permits may be issued
  - (c) the way in which permit conditions will be established; and
  - (d) the process by which applications for parking permits are to be made.
- (2) A **Resident parking permit** may be issued to a person whose circumstances are as follows—
  - (a) the person ordinarily resides full-time at an address situated within the Stadium Parking Area; and
  - (b) the person is not an hotel guest or an occupant of a serviced

- (c) the person is applying for the parking permit in respect of a motor vehicle that:
  - (i) is owned by and registered to the person; or
  - (ii) is registered to someone else, but the person applying for the parking permit has provided Council with evidence establishing that the person has an ongoing entitlement to use the vehicle; or
  - (iii) is registered to another person who provides essential care or services to person is applying for the parking permit.
- (3) A **Business parking permit** may be issued to a person whose circumstances are as follows—
  - (a) the person conducts a business from premises located at an address situated within the Stadium Parking Area; and
  - (b) the person is applying for the parking permit in respect of a motor vehicle that is necessarily parked in the Parking Area during a stadium event because:
    - (i) the vehicle is used in the conduct of the business at that time; or
    - (ii) the person or persons using the vehicle are customers of the business during the stadium event.
- (4) The Council will develop conditions for each category of parking permit to further the objects of the authorising law and will communicate relevant conditions to each permit holder at the time the person's permit is issued.
- (5) The Council will detail on its website the process by which a person may apply for a parking permit.
