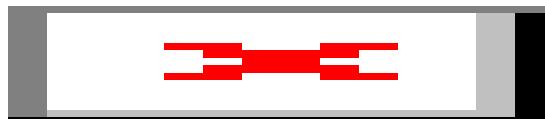

We act on behalf of the Applicant, Opulence Builders Group, in relation to the abovementioned development application.

For Council's consideration, please find **attached** our Response to Information Request (IR).

As per attached, we now wish to withdraw the 'stop' in accordance with s32.5 of the DA Rules.

Please also note that an additional allotment (adjoining Lot 0 on SP177536) has been added to the proposed development application, in response to Council's Information Request, to facilitate the use of the access easement. As the development is consistent with the terms of the easement, the owner of the burdened Lot (Lot 0 on SP177536) is not required to provide owner's consent. However, an amended DA Form 1 has been submitted to reflect this change.
